Dual-Enrollment Program Application 2009–2010



ADMISSION CRITERIA

- Fulfilling the minimum requirements does not guarantee admission to the Dual-Enrollment Program.
- Students with fewer than 24 transferable college credits must meet all UO admission requirements. (See page 4 of the UO admission application.)
- Transfer students qualify after completing 24 transferable credits with a 2.50 or higher GPA and meeting all other transfer admission requirements. (See page 4 of the UO admission application.)
- Transfer students with 36 or more transferable credits must meet all UO transfer admission requirements. (See page 4 of the UO admission application.)
- Post-baccalaureate students are not eligible.

APPLICATION FEE

A \$50 nonrefundable UO application fee is required of all applicants for admission. If you are a current UO student or have applied and paid a \$50 fee, no additional application fee is required. Currently enrolled UO students need to fill out an Admissions Information form at LCC Enrollment Services, but do not need to pay the LCC application fee. Currently enrolled Lane students have not paid the UO application fee and must therefore pay the fee.

APPLICATION AND DEADLINES

The admission application deadline is May 15. The dual application deadline is three weeks before the first day of classes for fall term and two weeks for winter, spring, and summer terms. Note: Dual students must be **admitted** to the UO by the dual application deadlines. The deadline for cancellation is the Friday of the first week of classes. Notify the UO in writing, including your name, UO ID number, and term you are canceling dual enrollment. Failure to enroll in any UO or LCC courses for one year will result in cancelling

your dual enrollment.

Admission to some programs requires submission of an additional application by an earlier deadline. Some programs may require submission of additional documents. For information on admission to specific programs, see page 1 of the UO admission application or contact Enrollment Services.

STUDENT RECORD RELEASE

As a condition of admission to the Dual-Enrollment Program, you must sign an agreement to release student record information to each institution. This allows Lane and the UO to share your student record information so that you can easily move back and forth between the two institutions.

FINANCIAL AID

Financial aid eligibility for students accepted into the Dual-Enrollment Program is determined as follows:

1. Lane evaluates and awards financial aid to applicants with 0–89 accepted credits by the UO. **Please note that financial aid from LCC cannot pay for any upper division classes at the UO.**
2. The UO evaluates and awards financial aid to applicants with 90 or more accepted credits by the UO. **Please note that financial aid from the UO cannot pay for any non-transferable courses, or vocational, technical, professional courses including nursing courses.**

All transcripts need to be submitted and evaluated prior to the first day of classes. The home school that awards financial aid is based on the number of accepted credits by the UO.

Dual-Enrollment Program students are expected to abide by the financial aid policies and procedures of the institution evaluating and awarding financial aid.

Dual-Enrollment Program students may apply for academic and departmental scholarships at either

TUITION AND FEES

Assessment of tuition and fees is based on the courses for which you register.

Lane tuition and fees are assessed for Lane courses; UO tuition and fees are assessed for UO courses. The institution that received the tuition and fees handles withdrawals and refunds in accordance with its rules and policies.

Tuition is assessed at resident or nonresident rates according to the residency classification of the student. Lane establishes residency criteria for its courses. The Oregon University System establishes residency criteria for UO courses.

Students who are admitted in the Dual-Enrollment Program and are **taking classes at both the UO and LCC will be responsible for paying fees and tuition at both institutions** as set forth in each institution's standard fee structure.

Students enrolled in the Dual-Enrollment Program and taking classes at only one institution are assessed fees according to that institution's standard fee structure. Students at one institution who want access to fee-based student services at the other institution may request its optional fee package.

Dual-Enrollment Program students have access to student services at both campuses. Fee-based student services are available to Dual-Enrollment Program students who have paid these fees.
