Deferral is only offered to first-time freshmen who wish to pursue a non-college experience, such as a gap year program, for up to one academic year from the time of initial admission. Please note:

- Submitting this form does not guarantee the approval of a deferral; such approval will be confirmed via e-mail.
- Students offered admission from the wait list are not permitted to defer their enrollment.
- The deferral option is not intended for students to begin or continue their college career elsewhere. In general, **a student may not attend another institution without jeopardizing their deferral status**. Requests for an exception to this must be clearly laid out in this request as part of the deferral description (see item #3 below).
- Any student deferring enrollment who has applied for **need-based financial aid** can submit a new FAFSA after October 1 for the following year. Any student deferring enrollment to the next academic year remains eligible for merit-based scholarships, assuming satisfactory performance in any subsequent academic work.
- Recipients of competitive awards (such as Stamps or DES) will retain their awards based on successful completion of their senior year.
- Deferral of admission to the Clark Honors College is granted solely at their discretion.
